

## Adopt-A-Street • Bike Trail • City Right of Way Volunteer Guidelines

### APPLICATION & CONTRACT

- Complete and submit application to KRCB
  - **Keep Riverside Clean & Beautiful (KRCB) • 3985 University Ave. • Riverside, CA • 92501**

- Upon an application being turned in, KRCB and the adopting organization agree on a one-mile stretch of Street, Bike Trail or City Right of Way to be adopted, located within the City of Riverside
- The application is then confirmed

### CLEANUP/MAINTENANCE

- Cleanup/maintenance projects are to be organized and managed by the adopting organization/group **six times** over a one-year period
  - Remove litter from streets & drains
  - Remove graffiti & tape from street poles & utility boxes
  - Pile palm fronds
  - Rake up weeds & green waste
- A completed report form for each cleanup/maintenance project is required
  - Report forms can be filled using any of the methods listed below:
    - On-line at [www.krcb.com/adoptastreet.cfm](http://www.krcb.com/adoptastreet.cfm)
    - Included in KRCB's tool loan packet, available at KRCB's office (as seen above)
- Remove all collected trash bags from their *Adopted Street, Bike Trail or City Right of Way* and **place trash bags in home or business garbage bins to be picked up during weekly collection**

### TOOL LOAN

- KRCB can loan out the following supplies: gloves, vests, trash pickers, trash bags, shovels, rakes, brooms
  - A full list of tools can be found by contacting KRCB's Project Coordinator (as seen above)
- To ensure tool availability, **please submit requests at least one week before the desired pickup date.**
- Volunteers pick up tools at the Greater Riverside Chambers of Commerce (3985 University Ave.) between the hours of 10:00 AM and 4:00 PM

## GRAFFITI REMOVAL

- KRCB provides graffiti removal packs to be used during a cleanup/maintenance project for utility boxes/signs/poles/guard rails
- If you spot graffiti near your site, please call it in to the City of Riverside by dialing **311**: 951-826-5311 or use the **311 app**. (*Available in your app store*)

## SAFETY RULES

- **Each volunteer must complete the City of Riverside/KRCB waiver form**
  - Waiver forms must be filled out on both sides by each volunteer on a *yearly* basis
  - One waiver form per volunteer is to be kept on file with KRCB for each year
- **Volunteers work WITHOUT City of Riverside/KRCB supervision, and WITHOUT traffic control**
- An adult volunteer who is designated team leader is responsible for conducting a safety briefing to all volunteers
  - Read aloud the “Project Instructions and Safety Requirements” from the back-side of the waiver form before each cleanup/maintenance project
- Volunteers under 14 years of age *must* be accompanied by a volunteer over 18 years during cleanup/maintenance projects
- Gloves, closed-toe shoes, and safety vests required entire during cleanup
- Masking requirements will follow CDC, CDPH, and Cal/OSHA guidelines at the time of the event

## RECOGNITION SIGNS

- Each adopted organization receives one recognition sign at the entrance on either side of *Adopted Street, Bike Trail or City Right of Way* **after** KRCB approves the application
- The adopting organization’s name will be printed on the signs, as decided by the adopting organization and disclosed to KRCB – 26 characters are the maximum
  - The application contains a section to indicate the name of your business/organization ***“as it is to appear on the recognition signs”***
  - Signs measure 24” x 30”
  - **Please no phone numbers, logos and websites**
- The City of Riverside has a \$60 fee for each sign that requires replacement.

## CANCELLATION

- Cancellation of *Adopted Street, Bike Trail or City Right of Way* if the adopting organization does not:
  - Conduct their first cleanup/maintenance project within 60 days **after** application is approved
  - Submit a report form indicating *six* cleanups within one year
- KRCB’s Project Coordinator will:
  - Send the organization a “reminder” that a cleanup/maintenance project be organized and reported within 60 days
